In cases where contributions are submitted by individuals on behalf of a legal person or organisation, the identity of the latter will be published. Contribution may also be shared within the network e.g. HMA or Working parties or Committees. Contributions received, together with the personal data of contributors, will be recorded in the Agency document management system, which is only accessible by EMA staff.
