# Introduction

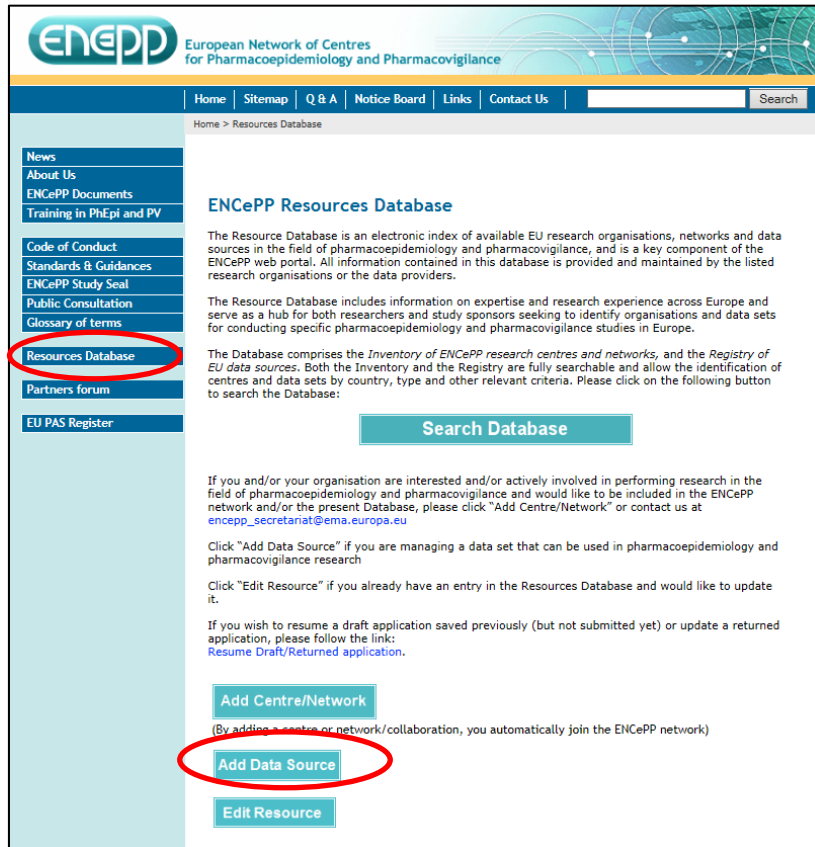
The aim of this document is to provide key points on:

- How to enter patient/disease registries.
- How to search patient/disease registries.

The main objective of the ENCePP inventory of registries is to be a network tool for disease and patient registries.

## A. How to enter your registry in the ENCePP Resources Database

1. Go to the ENCePP website Resources database:  
<http://www.encepp.eu/encepp/resourcesDatabase.jsp>
2. Select "Add Data Source"



3. After selecting "Add Data Source", you will have to choose a database classification (Centre/Network/Data Source). Select "Data source".
4. Register data source question: "Is data source maintained by a centre registered in the ENCePP inventory of research centres?" Select as appropriate (yes/no/don't know)
5. Questionnaire

Fields marked with (\*) are mandatory. They must be completed in order to move forward to the next question.

### 1. Contact details

1. Name of data source\*: complete name (long name)
2. Name under which the data source should be displayed in the inventory (max 50 characters)\*: short name – *add disease*

Please note that the patient registry disease must appear next to the short name. This is to ensure that at least the disease appears in one of the two above mentioned fields (that will help when searching specific disease patient registries). Please see the following example:

1. Contact details	
Name of data source	European Register for Multiple Sclerosis
Name under which the data source should be displayed in the inventory (e.g short name if one exists)	EUREMS - Multiple Sclerosis

### 2. How would the data source be most appropriately described? (Please choose all that apply):

Patient registries should have disease/case registries and exposure registry selected.

### 4. Which kinds of events are covered?

This field is very important when searching for a specific disease registry stakeholder.

'Specific event' should be selected.

The disease/s and/or the field disease must be included as this assists in searches. The row on the specific event should be for the field disease, and the free box text for all the diseases included in the registry, if more than one disease is included.

## **B. How to search for a registry in the ENCePP Resources Database**

1. Go to search database section: <http://www.encepp.eu/encepp/search.htm>
2. Select "Data Source"

It is recommended to search the following 3 options:

- *2.1 Search a registry by name*
- *2.2. Search a registry by disease*
- *2.3. Obtain the entire data sources list*

The above options are described below:

### ***2.1. Search a registry by name***

Type the complete name (long name) or short name (acronym) on the "name of data source" field.

### ***2.2. Search a registry by disease***

There are 2 different steps to find all the registries by disease:

1. Type the disease in the search field "name of data source"
2. You will retrieve registries with the disease on their "name of data source" or "short name" field (acronym) field.
